The meeting will be held in the last session of the Summit of First Nations Bailai, Gurang, Gooreng Gooreng, Taribelang Bunda People to be run from 15 – 17 December 2022. The Directors will be in attendance, and they encourage you to attend and participate.


A presentation in relation to the issue to be determined (see below) will be provided.

ISSUE TO BE DISCUSSED

1. Representation of Each First Nation in the Membership of the PBC by a Company

The PBC is proposing to amend its Rule Book to:

- implement the corporate structure previously presented to members and common law holders; and
- make the Rule Book compliant with requirements resulting from the amendment of Corporations (Aboriginal and Torres Strait Islander) Act 2006.



The changes to the Rule Book being proposed include the introduction of a new class of membership of the PBC in addition to common law holders who will remain eligible to be members of the PBC. This new class will provide for the corporations established by each of the Bailai, Gurang, Gooreng Gooreng and Taribelang Bunda Nations, for the purpose of receiving funds from the PBC and pursuing the economic, social and cultural development of their People, to become members of the PBC and to represent the common law holders of their Nation.

In accordance with the requirements of the *Native Title (Prescribed Body Corporate) Regulations 1999*, before admitting corporate members, the PBC must consult with and obtain the consent of the First Nations Bailai, Gurang, Gooreng Gooreng, Taribelang Bunda People.

The purpose of this authorisation meeting is to obtain the consent of the common law holders to the admission of the corporations as members of the PBC.
