## The State's proposed Yandaran Rural Fire Station Indigenous Land Use Agreement

The State of Queensland represented by the Queensland Fire and Emergency Services ('the State') seeks to renew Term Lease TL0/234405 ('the Lease') for a term of twenty (20) years.


The Lease is for Lot 13 on Crown Plan 900949 ('the Agreement Area') where the Yandaran Rural Fire Station is situated.

The State also seeks to validate all prior acts and all future acts over the Agreement Area.

To facilitate the State's proposal, The First Nations Bailai, Gurang, Gooreng Gooreng, Taribelang Bunda People Aboriginal Corporation RNTBC (ICN: 8650) ('the Corporation') are proposing to enter into an Indigenous Land Use Agreement (Body Corporate Agreement) pursuant to Subdivision B of Division 3 of Part 2 of the Native Title Act 1993 (Cth) ('the ILUA').

## The proposed ILUA Agreement Area

The proposed ILUA 'Agreement Area' comprises the area of the Lease as shown on the map below. The Lease covers 691 square metres at Yandaran and is located within the boundaries of the Bailai, Gurang, Gooreng Gooreng, Taribelang Bunda People's Native Title Determination (QCD2017/010; QUD6026/2001) ('the Determination').



## <u>First Nations Bailai, Gurang, Gooreng Gooreng, Taribelang Bunda People Consultation</u> and Consent

In accordance with the requirements of the *Native Title (Prescribed Body Corporate)* Regulations 1999 and the Corporation's Rule Book, before entering into the ILUA, the Corporation must consult with and obtain the First Nations Bailai, Gurang, Gooreng Gooreng, Taribelang Bunda People's ('the BGGGTB People) consent.
