BUSINESS CERTIFICATION ELIGIBILITY PROCESS

Certification Criteria

Eligibility for Port Curtis Coral Coast Limited certification consists of:

- Minimum 51% ownership by PCCC descendants
- Confirmation of PCCC descent on the application form—has to be 51% minimum;
- Located in Australia
- The Company must be controlled and managed by a Chief Executive Officer who is a PCCC descendant
- Key business decisions regarding the company's finances, operations, personnel and strategy should be controlled by a PCCC descendant
- The Company must not be a registered charity and it should generate the majority of its revenue through providing goods or services. These consist of mostly Partnerships, Sole Traders, and Proprietary Limited Companies.

The Two (2) Steps in the Certification Process are:

Step 1: Register with Port Curtis Coral Coast Limited by emailing reception@pccctrust.com.au. Indicate your interest in certification.

Step 2: Submit the completed application form with all supporting documentation to reception@pccctrust.com.au

Definition of PCCC Descendant

A PCCC descendant is a descendant from the following groups; Gooreng Gooreng, Gurang, Byellee, and/or Bunda.

Step 3: Confirmation of PCCC Descent

The applicant is required to provide confirmation of PCCC group descent.

Confirmation of Aboriginality

The PCCC descendant must provide confirmation of his or her Aboriginality. There are two different types of confirmation that Port Curtis Coral Coast Limited accepts:

Certificate of Aboriginality

A letter from an Indigenous organisation confirming Aboriginality from one of the following organisations:

- Aboriginal and/or Torres Strait Islander land and/or sea councils,
- Aboriginal and/or Torres Strait Islander medical centres,
- Aboriginal and/or Torres Strait Islander legal services,
- Aboriginal and/or Torres Strait Islander organisations registered with Office of the Registrar of Indigenous Corporations (ORIC), or
- Aboriginal and/or Torres Strait Islander community justice group.

OR;

PCCC Confirmation of Aboriginality Form

A signed Port Curtis Coral Coast Limited Confirmation of Aboriginality Form.

The form requires the applicant to provide PCCC Elder Confirmation (name and signature), that the applicant is of Aboriginal descent, is recognised and accepted as a traditional owner of one of the four tribal groups (Gooreng Gooreng, Gurang, Bunda, Byellee), and to identify their PCCC Apical Ancestor.

Step 4: Port Curtis Coral Coast Ltd Board of Directors will assess your application for endorsement.

Step 5: After the decision has been endorsed by the PCCC Ltd Board, you will be notified of the outcome. If you are advised that you were successful in the application process, you will be sent a form to complete where you agree to the Terms and Condition for Certified PCCC Businesses. Once we receive this form your business will become a Certified PCCC Ltd Business.

Terms and Conditions for Certified PCCC Businesses:

Certification as a PCCC entitles your business to the following:

- The right to promote your business as a PCCC Ltd Certified Business
- The use of the PCCC Ltd Certified Business Logo on your company's profile
- A free listing of your Company as a PCCC Ltd Certified Business online via our website - www.pccctrust.com.au.

The Business acknowledges that certification is not a guarantee that the Company will be selected for business opportunities, and PCCC Ltd is not obliged to introduce or broker work for Certified PCCC Ltd Businesses.

PCCC Ltd reserves the right to revoke certification if the Business does not comply with the following terms and conditions.

The PCCC Ltd Certified Business must:

1. comply with any PCCC Ltd Business code of conduct;
2. not misrepresent, advertise or falsely state or promote that the business is a subsidiary or affiliate of PCCC Ltd.
3. not use the name PCCC Ltd or log without PCCC's permission
4. advise PCCC Ltd of any changes to the control and management or the ownership of the business within 30 days of the change.

Failure to comply with these conditions will result in automatic cancellation of certification.
