PCCC Bailai (Byellee) Director

Eligibility - To be eligible for appointment as a PCCC Bailai (Byellee) Director a person must:

- (a) Be a PCCC Member of good standing;
- (b) Be nominated by the Bailai (Byellee) members;
- (c) Not be in breach of any of the Member's obligations pursuant to (the) Constitution;
- (d) Have submitted a curriculum vitae, typed in the English language, to the Board at the time of nomination;
- (e) Hold a level of general educational qualifications as may be determined appropriate by the Board from time to time;
- (f) Be a person of good fame and character within the PCCC People and the larger community;
- (g) Have, or have applied for, a Directors Identification Number;
- (h) Not be disqualified from managing a corporation under Part 2D 6 of the Corporations Act; and
- (i) Not be disqualified from being a responsible person under the Australian Charities and Not-for-profits Commission Act.

Term of Office - PCCC Directors have a term of 3 years.

Selection and Appointment Process

The Board will appoint a Selection Committee who will consider each of the EOI nominations received from eligible individuals and make their recommendations and will take into account the following:

- (a) the number of director vacancies to be filled;
- (b) ability to read and understand reports of the financial accounts;
- (c) leadership experience;
- (d) experience with Directorships;

- (e) standing and respect amongst the Bailai (Byellee) People;
 - (f) diversity in age;
 - (g) skills or experience in one or more of the following areas:
 - i. Indigenous Affairs, Native Title or cultural heritage management;
 - ii. Business Management;
 - iii. Accounting or Finance;
 - iv. Risk Management;
 - v. Legal or Compliance;
 - vi. Information Technology or Information Management;
 - vii. Media or Communications;
 - viii. Corporate Governance;
 - ix. Human Resource Management; and
 - x. Community Engagement and Development

The Selection Committee will recommend the EOI nominees to be appointed to vacant Director positions and the Bailai (Byellee) PCCC Members will vote on the endorsement of each recommended nominee.
